General Business	Discussion	Action
Incident reports	No incidents have been reported this month. 2 radios are fully charged in the shed. Pete is cycling them and charging them as needed. They do discharge if they have been left on so he is keeping an eye on the battery indicator on the radios. They go into the shed/room beside the toilets. There is a key in our main shed. There is only one plug so we need a multi box so we can charge more than one at a time. Several crews have noticed an unlit motor boat speeding around the marina and channel in the dark, both in the mornings and in the evening. It's something to watch out for.	
Gear and Maintenance	After Portage Julie washed all the skirts and hoops. There are several hoops missing and there is a set of homemade blue ones that are still taped together. We need to do an inventory and order more from MoanaNui before next racing season. 1 of the skirts has stitching that needs to be repaired. The skirts on the Mahimahi are very hard to fit. They need to have the seat positions marked so that at least you know where to start. There are now rear pole fittings for lights or cameras on 2 waka.	Tony/Julie to look at hoops and skirts and repairs/replacements needed.
Membership	We have had 2 memberships for the year starting July 1 st . Both have filled out the website membership form online.	
Towing	The last 2 'away' events we have had an issue about how to get the waka there. Jeff has sourced suitable towing vehicles both times and has been happy to drive them. The truck was great, the van taken to Golden Bay was a little 'sus' as the it only had 2 waka on and the brakes were a little 'squishy' coming down the Takaka Hill.	

There was discussion around whether the club should buy a vehicle or continue to hire if suitable vehicles can be sourced. Buying involves all sorts of costs both upfront and R&M. Towing 4 waka is hard on a vehicle. For the number of trips away (approx. 5/year) it is much cleaner to hire.

3 day hire to Picton cost \$251 + fuel

2 day hire to Golden Bay cost \$198 + fuel (passengers in van

2 day hire to Golden Bay cost \$198 + fuel (passengers in van further reduced costs)

Char moved that for all 'top of the South' club events, each paddler attending the event will be required to pay \$5 towards towing. This will go towards the hire and fuel cost for the trip with the club covering the difference. Further away events will be considered on a case by case basis. Where applicable the \$5 fee will be added to the race registration. Seconded by Katie.

There was then discussion around whether or not we 'prebook' vehicles for known events to make sure we have one.

The committee would like to thank Jeff for all the work he has put into securing and driving the vehicles for the last 2 away events.

Lakes race & Sanctioning

Confirming that the dates for the Lakes Race is 9th & 10th February and this is the weekend before Takapuna. DoC is very happy with our event and wondered if we could build more community involvement into it. We have the Fun race at lunchtime which has been a hit with locals. There are new people looking after the hall and Helen has made contact with them but the booking has not been confirmed as yet.

This is our 10th anniversary of the race – is it too much to sanction it? What would we gain from sanctioning? Pete talked to Viv at Icebreaker. No one from NKOA was helping with the event or even in attendance. It took all Viv's time to organise the races and timing etc. Rob From Waitaha thought that sanctioning can actually put people off especially the youth who might not be affiliated with NKOA (The Chch school crews that traditionally race at the Lakes). Golden Bay's opinion was that they like it non sanctioned. What we would get:

- It would be classified as a Level 2 events (less than 500 competitors)
- The event would be advertised on NKOA website
- NKOA would provide liability insurance (we already have that covered)
- They set specific safety standards (we have good safety standards in place)
- We would get access to the survey tool survey monkey (we could easily set that up ourselves)
- Online entries are mandatory (but still a lots of last minute changes going by Waka Te Tasman and Icebreaker)
- NKOA would provide waiver forms and safety templates (which we already have)

Do we want it a local event or as a more national or international event? There are not a lot of waka in the Top

	of the South so if it grew too big we would have trouble providing waka for bigger numbers. Registration and timing are the hard jobs but we could look at ways to do this differently. Look at buying an app if it can be used across several devices, then we could use it at the South Island Masters Games as well. Char proposed that we research buying a timing app (e.g. ProTimer professional version) looking at its cost for timing such events as the Winter series, South Island Masters Games, Lakes race. What ever the program it must be able to handle splits. Lakes race sub committed needs to meet soon. Pete is still willing to be the race director. Confirmed other members are Gina, Kilmeny, Katie, Rosalie, Tony. Need to set a date for the first meeting. Catering: Kudos is happy to do the catering again.		
Membership Fees	The committee was in agreement that there would be no late fee levy on late memberships as its too hard to implement. Just 'hound' members to pay.		
Water Sports Alliance	Zoe and Julie attended a meeting on Thursday for the Alliance. It is starting to get some traction and it now seems to be on a fast track. The council is looking at putting in lanes for the marina launch ramp (like at Picton) and at using and modifying existing buildings instead of building a purpose built facility. Thursday's meeting was to figure out how the land space could be best used to fit the needs of all concerned.		
AGM	Public notices need to be put into the free newspapers (community notices) before the AGM.		
Alliance with Whakatu	Char posed the question of Whakatu paddlers wanting to know if they can use our OC2s for training. There has been more mixing between the 2 clubs recently with the Maitahi members paddling with Whakatu mens sprints night and Whakatu paddlers being included in Maitahi crews. Discussion about when it is a casual occurrence, and there are Maitahi paddlers in the waka being borrowed, then paddlers may not need to be paid up members of the other club. Katie was concerned, in the case of the OC2s, that maintenance is always ongoing. Also concerned expressed about how to book waka, as we use Teamer, and nonmembers can't check or use that. In the April 2017 minutes it was noted that Zoe had been asked by Huriana and Leila about our membership rates and what the rules were for the use of our waka. Whakatu's sign off procedures seem to be similar to ours and it would be a matter of Pete and Hayden liaising. Fees would need to be paid to both clubs for paddlers wishing to paddle with both clubs. We need to get more definition around what Whakatu really would like to do, so it needs to go on the agenda for next month.	Put on July's agenda for further discussion.
